

## East Moline Correctional Center: Prisoner Survey Results from JHA's Monitoring Visit Conducted March 3, 2020

East Moline Correctional Center is a male minimum-security prison that housed 1,126 people on the day of JHA's monitoring visit. JHA collected 461 surveys from people incarcerated at the facility (40.94% of the population). Responses to survey questions are reported below.<sup>1</sup>
