

Data Set Modifications for the Prison Profile 12-31-20

AdminType2 [Admission Type 2] (IDOC's Admission Type variable dummy coded):

B54899 listed as "Not in IDOC custody" (coded as 6) was manually recoded to "Discharged & recommitted" (coded as 4) because person is in IDOC custody at Danville CC as of 1-29-21 (also in prior searches). Information on IDOC inmate locator indicates this person was discharged for two 1993 offenses, then recommitted for two additional offenses charged in 2009 (long after full sentence expired for 1993 offenses).

The following cases had Admission Type recoded (JHA recodes--IDOC variable not changed) because all are listed as MSR/Parole Violators, but all are currently serving a life sentence; AdminType4 recoded to 'Unknown' (coded as 4) and AdminType5 recoded to 'Unknown' (coded as 3):

Sentence:

K97491 changed from 4 months to 28 months; IDOC inmate locator indicates person was sentenced to 850 days (27.95 months) by court for controlling case

Projected Mandatory Supervised Release Date & Projected Discharge Date:

Several cells in the column for this variable were blank in IDOC's population data set, however, the projected MSR date was listed on IDOC's inmate locator for the following people as of 2-22-2021:

M24156: MSR 9/22/2045; Discharge 9/24/2048
M26844: MSR 9/17/2021; Discharge 9/24/2021 (person is a tech MSR violator)
M47769: MSR 5/11/2066; Discharge 9/11/2069

The following person does not have a projected MSR date or discharge date listed in the IDOC inmate locator; the projected MSR date was calculated by JHA ((sentence years * .85) + custody date listed on IDOC inmate locator)

Crime Class:

The three people listed below were listed as Class M in the IDOC data set, but they should be Class X:

K72060: changed to Class X for Crime Class, and recoded to Class X (coded as 2) in CrimeClass2 and CrimeClass3
M26609: same
B60722: same

Additional Crime Class manual recode

B67703: Class 2 (coded as 4); person's holding offense is SEX OFFENDER GIVE FALSE INFO/2ND, a Class 2 felony, committed while on MSR for Class 1 (was listed by IDOC as Class X)

Holding Offense and Crime Class variable listed in IDOC data set incorrect (all people serving court imposed life sentence); search for incorrect values limited to Class 1 thru 3 who are serving Life in IDOC data set; 6 people were found in the data set whose Crime Class designation did not match up with court imposed sentence (example: a person with Class 3 felony listed as Holding Offense who was sentenced to LIFE); After looking up these people on IDOC IM Locator, we determined the true holding offense to be Murder or Class X rather than the lower level felony indicated in the IDOC data set. Thus, the value for Holding Offense and Crime Class and all JHA recodes were changed for the following people:

B52858: true Holding Offense: AGG CRIM SEX ASSAULT/BODILY HARM (coded as 2023); Crime Class: Class X (coded as 2); Offense Types (1, 2, 3, 4, 5, 7, 8, 9) recoded to sex offense: 2, 3, 1, 3, 3, 3, 0, 3

N60033: true Holding Offense: MURDER/INTENT TO KILL/INJURE (coded as 240); Crime Class: Murder (coded as 1); Offense Types (1, 2, 3, 4, 5, 7, 8, 9) recoded to Person & Person Death/Phys Injury: 1, 1, 1, 1, 1, 1, 1, 1

B82995: true Holding Offense: MURDER/INTENT TO KILL/INJURE (coded as 240); Crime Class: Murder (coded as 1); Offense Types (1, 2, 3, 4, 5, 7, 8, 9) recoded to Person & Person Death/Phys Injury: 1, 1, 1, 1, 1, 1, 1, 1

N91067: true Holding Offense: MURDER/INTENT TO KILL/INJURE (coded as 240); Crime Class: Murder (coded as 1); Offense Types (1, 2, 3, 4, 5, 7, 8, 9) recoded to Person & Person Death/Phys Injury: 1, 1, 1, 1, 1, 1, 0, 1

C66348: true Holding Offense: MURDER/INTENT TO KILL/INJURE (coded as 240); Crime Class: Murder (coded as 1); Offense Types (1, 2, 3, 4, 5, 7, 8, 9) recoded to Person & Person Death/Phys Injury: 1, 1, 1, 1, 1, 1, 0, 1; A C number who was convicted for new offense while on parole is a special circumstance, but IDOC has projected MSR date listed as 2042, so the most serious offense pre-parole is what is being used as the controlling case, not the Class 2 sex offense from 2001
