Introduction

East Moline Correctional Center is a minimum-security male prison within the Illinois Department of Corrections (IDOC) that housed 449 people on June 29, 2022. The John Howard Association of Illinois (JHA) conducted a modified short Measuring the Quality of Prison Life (MQPL) survey by providing enough survey packets (consisting of the MQPL survey, an informed consent notice/instruction sheet, and a privileged mail prepaid business reply envelope addressed to JHA) so that every person incarcerated at East Moline had an opportunity to participate in the voluntary and anonymous survey if they chose to do so. JHA received 131 responses to the MQPL survey from people at East Moline through the end of 2022, representing approximately 29.2% of the static population. JHA also conducted a monitoring visit of the prison close in time to survey distribution.

Below are the comments from the MQPL surveys for the open-ended survey questions followed by marginalia comments. Please note:

- 5. The buildings are not air conditioned and falling apart. Surrounded by buildings that are condemned. Facility is outdated and should be closed. Can't provide proper food, milk or education.
- 6. The staff and Cos are disrespectful and treat us like we are no one. The heat and hot water doesn't work in the winter, and the heat blows out of the vents in spring and summer and the hot water goes in and out causing it to burn you. The staff and Cos eat better with our food than we do, and our healthcare is horrible.
- 7. Staff don't know how to deal with inmates who has been locked up for over 20 years.
- 8. Not enough staff so inmates can utilize programs to better ourselves for release.
- 9. The staff has no respect for you and treat you like trash cause you're incarcerated.

- 22. Officers with petty, antagonistic behavior, the lack of vocational courses, no way to earn GEDs. Something is always malfunctioning (i.e. heat, A/C, hot water)

- 48. Gangs are allowed to control the phones, washing machines, and tables in dayroom
- 49. All are considered illiterate. I did my high school in [REDACTED]. Then Bachelors Education 4 years Masters of Arts 3 years Masters Business Management Diploma Education 3 years PhD D-Hum they nullified all that and forced me to do stupid exam!!!! For [ILLEGIBLE]
- 50. The 10% of the staff even going to the chain of command tends to side with staff vs. directly offer a better compromising solution. The few inmates who don't like new rules or current rules to be enforced don't like it call Springfield and call bias. Example ice when a CO says 1 scoop until everyone gets some ice esp. summertime, they get in an uproar because they can't get their bags of ice first. That leads to others not getting any at all. And a few inmates have a "kid" mentality and it changes the whole atmosphere of the wing. Those should be housed together with doors that close after 9:30 final count as they're the ones to take too much advantage a minimum security offers putting more scrutiny on the wing and such. Maintenance supervisor a Big

- issue. Won't do the things that will bring more peace and [ILLEGIBLE] to the majority. Like keeping an ice machine (a new one) functioning. Or repair showers or leaking ceiling light.
- 51. You get denied for things without actually bean put in with no viable explanation like EDSC, work release, transfers
- 52. treatment and lack of access to person needs
- 53. treatment by staff is terrible, poor programs, horrible healthcare
- 54. They won't give certain jobs of higher pay, or certain educational opportunities based on offense and not the individual
- 55. Counselors and staff supervisors are not very helpful when you ask an important question about certain things. They try to give me an answer to my problem by ignoring the real question like making something up.
- 56. You cannot talk to females down here much because sexual cases.
- 57. Treatment by staff and healthcare. Not enough programs. sense of hopelessness
- 58. We have a [ILLEGIBLE] that makes medical decisions without patient doctor conferencing. For some reason they seem to be unorganized.

- 60. The living condition here, no schooling, being too far from family, staff put your safety at risk, then when you have to fight, you get blamed
- 61. The endurance of a slow mental breaking on top of the systemic strain on resources finances and contact with your family.
- 62. A lot of negative people (individuals) A lot of negative staff that look down at all individuals
- 63. There is no chance for success.

- 65. They lie about everything when it comes to people with sex offenses. They treat and talk to you like you are subhuman and they have the worst turnaround at the door policy when it comes to sex offenders telling you that they are looking for housing knowing 100% that no housing or living facilities exist in the state of Illinois it was closed back in 2013 East St. Louis.
- 66. I can't get medications I need for pain I'm totally disabled. I have a [REDACTED MEDICAL DEVICE] I can't use the way I'm supposed to. They won't let me.

- 70. Lack of proper maintenance, mechanical and janitorial
- 71. Healthcare Staff aggressive attitudes Lack of programs
- 72. Here at East Moline staff treats incarcerated individuals like less than people. They lie and never explain their reasons even if you ask a direct and clear question, they either ignore you or answer something that you never asked.
- 73. They're always on different pages when it comes to enforcing the rules.

- 75. How staff treat and talk to inmates.

- 77. The Lt., C.O. all bad and the food is bad too.

- 91. They write our names and ID number on our KN95 mask in marker and make us wear the mask. It's like sniffing a marker. I've been having headaches, also I been getting dizzy from sniffing he marker that's on my mask. This is East Moline. They write us tickets if we don't wear the mask that they wrote on in marker.
- 92. Wasting life
- 93. The dietary has rats and roaches there's not enough food in trays. The staff are overaggressive with no repercussions. The dayroom hours for this level prison is not adequate enough. The washers and dryers stay broke. Black mold everywhere.
- 94. Infrastructure Living environment
- 95. The teachers don't want to come to work there is no substance abuse programs
- 96. The food and the officers cause some of them come to work to control others.
- 97. Getting along with others
- 98. Extreme heat in housing units both in the winter because of steam heat with no thermostats and in the summer with no working cooling system and no ventilation. Poor food items in dietary with no real nutritional value. No milk served in dietary. Not adhering to 730 ILCS 5/3-6-3(2)(3.0)(4.2) Rules and Regulations for sentence Credit
- 99. Water, Ice, phones, some sergeants and COs are disrespectful, phones are controlled by incarcerated individuals, the heat inside is unbearable. Commissary never has a stock of shoes, clothes, electronics. Dietary is full of roaches. Yard is too limited with quality and quantity of weights.
- 100. Assignment mistakes/pay mistakes. Food in dietary. Bugs in dietary. Housing unit maintenance. Hygiene supplies

- 102. Some cells are molded. We're allowed one cup of ice a day in the summer time and the building has no AC.

- Get rid of the racist officer and staff.
- BURN IT DOWN
- 4. More check up from Springfield from people that are really concerned about individuals in custody.
- 5. Close facility or total rehab. Get rid of roaches in dietary. Provide milk daily. Provide food that won't be just thrown away by every inmate. Provide a humane environment.
- 6. To be honest I know my suggestions don't really matter, I'm just an incarcerated individual.
- 7. Why, it's never going to happen!!!
- 8. Someone to pay more attention to people health and living situations here.
- 9. A new warden be installed.
- 10. Stop the policy of not being able to cell inside your own race. Blacks can cell together but Mexican and whites can't. This is not fair and is being taken advantage of.
- 11. RETRAINING!!!
- 12. Try better techniques when they are dealing with Individuals in custody.
- 13. Close this place down that would be the improvement!
- 14. To treat others with empathy and obey the law!
- 15. Staff leave their problems at home

- 16. 1. I do believe the commissary officers need to be revued and looked into because we have such a drastic change, and lack of having certain items such as hygiene. 2. We need to have at least 2 yards a day especially for 1st shift workers, we barely get any movement in this minimum camp
- 17. Close down, because nothing works here and the staff is the worst I have ever seen in my life, it's a lot of us that don't feel safe.
- 18. There should be surveys that prisoners take to improve prisons. They are the ones locked up.
- 19. Better food/Run yard and gym daily Better ADA assistance/Having a working water fountain on deck
- 20. More meaningful vocation courses. Better communication from staff.
- 21. Fire Lt. [NAME REDACTED] and a lot of other staff
- 22. Seeing as how all these housing units are actually condemned, why not just shut this place down? Or at the very least lower the population while you continued with your patchwork.
- 23. If they had healthier food where we just don't pack on pounds, get extreme acid, indigestion and heartburn, more variety of channels on TV, extra inmate clothing for the week, especially for those who work on assignments and dietary. Follow the exact sentence time that was issued to be at court which is only 6 months!
- 24. Quit hiring the mentally handicapped to run this prison and IDOC. Put cameras in this facility. Fix the Chow Hall Floor. Water is leaking through the Chow Hall Floor down into offender's legal storage area.

- 27. Everything, with the way staff talks to us, the way of living and not having enough cleaning materials to clean our environment.

- 44. First of all the staff need to be retrained to be more respectable to a person need and learn how to communicate with that person... Second more programs that will fix our needs on release....
- 45. Staff to get more involved and take control of phones and kick out any active gang members to prisons where they are locked behind doors
- 46. Close them all shit!!!
- 47. Honor the good time for programs taken. Put those in programs and school together in Housing Unit 3 and 4 and fix the AC and make it better. Anyone "goofing" around give 1 warning before kicking out for 2 months or so. This will show when you're there it's serious time to focus on self, which radiates to the others in the same environment. This will help tremendously! Have a Housing Unit for those who don't want to take programs or can't due to time to be housed together, and move the "kids" to another wing. It'd suck for the one CO to work it, but put the true "problematic" COs there. But doing this will not penalize the rest when they're gearing up to be released stay focused. Maintenance needs to get their ass moving. The Supervisor walks around with the Warden all the time and yes does get nitpicked about minor problems but some are legit and for the whole wing, and [ILLEGIBLE] won't care. Nothing gets done. The electrician, carpenter they get the job done and right right away sometimes they're even limited by the supervisor.
- 48. The clinical services staff need to be more hands on and help more with things (concerns) for us.
- 49. Change in upper management Wardens/counselor
- 50. More good programs. Day for Day credit for All jobs and schooling, sensitivity training, nurse [NAME REDACTED] should be fired.

- 1. Close down EMCC. It's old and unfit for any human to live here. And the staff treats people like they want to and nothing is done about it.
- 2. People with 85% who are wrongfully convicted should get an opportunity at work release or house arrest. WE ARE NOT ANIMALS WE ARE HUMAN BEINGS!!!
- 3. There is very little schooling opportunities. Very little incentive to become a better person. Very little job opportunity for vocational just slave labor type jobs janitorial -

- need a more human rights approach. Too many officers getting overtime for basically nothing or sleeping on the job.
- 4. You all need to take a real look into this prison and ask the inmates real questions. This place should be shut down. It's not suitable to live in!!!
- 5. The problem here the chow hall is filthy. The people incarcerated are not the problem it's certain staff members who are disrespectful, unprofessional, and untrained.
- 6. Overall not bad living conditions is a big part of doing good time. But racial environment exist in every prison. Two people who can cell together should be able to do so. Not force race boundaries.
- 7. Over the past couple weeks it's been in the 90-100 degrees and there are over 100 grown men that has to share 5 gallons of water per shift. And when ask officers for more they say it's not in the rulebook that they must supply ice water at all!
- 8. Help this facility with they reviewing for EDSC and they process of being put into programs. Help the next person get out.
- 9. This place needs to be investigated from an independent outside source no one really cares not even you!
- 10. This prison is selective on who and when receives opportunity even if you are well behaved no disciplinary tickets. People should be given opportunity when earning the privilege. Do not hold people to a double standard. (Violation of 5th Amendment)
- 11. ADA staff here sucks
- 12. The teachers only come to A.B.E. school 4 days a week, most only come 2-3 days a week. The classrooms hold approx. 20 people however they only put 6-12 in a class at a time. It takes 6 months to complete mandatory A.B.E. schooling and another 6 months for advanced A.B.E. schooling/that's 3 months for each class. That means once you're in school it could take up to 1 year to just get started on G.E.D. schooling. THIS NEEDS TO CHANGE!!! I believe they are doing this for population control. The average person does not have enough time to complete their G.E.D. while incarcerated because of the days the teachers show up actually and how many they put in each class. This needs to be looked at!!
- 13. This is a horrible place to be I have been threatened, walked in the shower on, this place needs to be investigated and they need to come and talk to some of the inmates, I am so depressed every day here, I feel sadness, anger, fear, anxiety every day. I HATE it here.
- 14. They should create a program that lets prisoners recreate the prison to fit needs of others and themselves so that they leave a better mark to not return but be remembered.
- 15. I have seen ADA inmates get harassed constantly by multiple staff. Almost daily sometimes, [IDENTIFYING INFORMATION REDACTED]
- 16. Fire Lt. [NAME REDACTED], they need to help people more to prepare them for the world, more classes
- 17. What's the point in this survey? Every year you all do a survey and you must know how run down and unprofessional this staff is and place should not have anybody living here. And nothing improves here. No positive changes. What's the point? COVID-19 is still killing people making people sick, and still they stack us on top of

- each other. Is it an attempt to slowly kill us off? Is the JHA and the IDOC in bed together? Is this some kind of thing you all do to keep getting funded? How can you be an independent correctional monitoring organization and not force positive changes. What good is this information if you're not going to do anything with it. Help or stop all to oversight stuff! It's a LIE!
- 18. I thank you for your concerns and questions about my stay at East Moline. I look at this prison more like a summer camp/outdoor education/recovery treatment for mental, drug and alcohol and behavioral disabilities. I just hope I do only 6 months here which is what the judge ordered me to serve but receiving my M.S.R. date it's dated [DATE REDACTED]. I hope they don't add on extra time to my sentence and would like for someone to correct my M.S.R. date and calculations sheet. Thank you and God bless John Howard Association!
- 19. Had Augustana not started their B.A. Program here, I would have done anything to transfer to another prison. This administration to learn to communicate. IDOC needs to modernize. We have no computer to type a clemency, yet they (clemency) have to be typed.
- 20. Do good to get out
- 21. East Moline fails to properly care for medical and/or ADA needs of many of us! The security staff often times bullies older and inmates with special needs at East Moline.
- 22. All staff and C/O's should be made to continue to wear their MASK at all time while at work!
- 23. More yard and more school
- 24. N/A
- 25. There is a level of corruption at this facility that most would never believe unless they saw if for themselves. The problem is no one believes what is really happening. They believe the false report written by staff.
- 26. Why. Nobody gives a dam about the overall welfare of the inmates. Just a fraternity of COs, male and female collecting paychecks and absolutely nothing more.
- 27. Been incarcerated 21 years, hope to be released before my mother past with so many medical issues. Have [NUMBER REDACTED] years remaining. Been here over 3 years, on waiting list hoping for Kewanee re-entry center, and need a change for family motivation. Been gone so long I feel my family has given up. Need more help before release. "We need sentencing credit for Truth-in-Sentencing"
- 28. Do a complete overhaul of ordering commissary items bring back ice cream at a lower price more choices in flavors and also name brand sodas at a reasonable price and microwave food items put microwave ovens on every unit in East Moline Correctional Center. Inmate Trust Fund can pay for each oven! This can be done. I was in East Moline before [in 1990s]! On A wing we all cleaned after each use.
- 29. The survey is good, but it doesn't target healthcare at all. This is supposed to be a low security minimum, but staff here act like they want it to be much worse, they antagonize and instigate situations. They make my time so much harder.
- 30. Good overall?
- 31. Why is nothing changing but you keep giving us surveys

- 32. There are roaches in the food, and the cooks sometimes don't wear gloves Something needs be done no one wants 2 do nothing
- 33. I do see how this place is trying to improve, but the lack of leadership will hold this place back, and the staff will never fall in line because of it...
- 34. I appreciate the John Howard Association involvement but East Moline in a whole meets bare minimum requirements when it comes to issuing inmates requirements that they need.
- 35. They have no single respect for humanity. They have no single respect for my religion Islam. I'm a Muslim and there are 30 Muslims. [REDACTED]
- 36. This place can be a truly influential place for those who are close to being released. This place can put the mindset in others that it's time to prepare, put the game face on and be ready to tackle release head on. A few adjustments said above, and throughout my survey will help fine tune this. Also Springfield, IDOC and the State needs to play ball. If this place is to remain here, shore up their infrastructure - the old tunnels, sewer systems that have been here since late 1800s - and where their electricity, water, sewer lines run through, and which will stop the sinkholes - the land being washed through. Then fix up the buildings. This facility is so unique and a huge benefit being the way it is close to society. It's like "freedom" is right there, RIGHT there, but I still have a fence between. That's what you're striving for. To get THERE! That is inspiration and the facility is like a society, all different and spread out housing units and such. A pain for maintenance, but a beauty for the psych, mental health, and preparation for the individual in custody to be more focused and determined. One day, I'd love to see a work detail, a van or two after careful consideration, to go to the John Deere factory to work - say 7am-1pm. They can get some real world experience, allow that as a reference to a resume and more importantly to save up some money to help transition or establish a place to stay that may be required to parole. An honor dorm. Yes there may be an idiot or two - they're everywhere, but would be taken seriously by majority. And sex crimes, don't get good time, a level of benefits that can't be passed. Certain and better jobs, parole as lack of housing available out in society, etc. A chance should be given here too. Or a different job or work detail that's about equivalent but within acceptable reason - maybe even on grounds should be tried. They have skills too. And leave the trees alone! It's an awesome perk to being here. The leaves changing, to the birds and wildlife using them. And plant some damn flowers or flowerbeds. Make it look and smell a little good. Use the horticulture class or get one. Thanks for listening.
- 37. Good survey very general though
- 38. This facility is practicing racist and retaliatory practices inhumane treatment living in unsafe living conditions breathing mold and asbestos drinking water that is colored and foul smelling. Dietary conditions are unsafe eating to eat in with roaches and pest such as mice and maggots. This place really needs an outside audit and the IDPH to come in and do a thorough walk through of all living areas. There are no working water fountains and we are not given the opportunity to purchase safe drinking water. The memo enclosed is proof of how we are being treated by Asst. Warden [NAME REDACTED] Thank you.

- 39. This people talk to me like I'm a dog. I need help, I don't know what to do in society, I'm on my 9th prison bit!! I don't know what to do and no one here does either. I've been denied Kewanee, I've been denied work release. The next time the police will have to kill me, I will not go through this again, but I don't know how to live out there. I'm not going to a shelter or halfway house. But I have no where to go. I have no money, no clothes, no transportation. I have no options. My life sucks, it always has. So you tell me what the plan is? If you people truly care, you explain to me what I'm suppose to do out there.
- 40. If they trust us they would let us work outside the gates more, they do not trust us to wash the outside window
- 41. No one wants to fill these surveys out, they all say it's pointless, that you don't care. There's no hope here. I don't believe anyone really cares. Do you care? What are you gonna do to help?
- 42. Well all inmates should be treat better as human being and do test on these staff and white shirt
- 43. Staff say taxpayers pay to make sure they make our time hell. That's not their job. And the state pay ain't right a case of noodles is 10.56 State pay \$10 a month if you have a job you only get \$20 a month. You're forced to get in debt with gangs to get by.
- 44. Thanks
- 45. Thank you for sending the survey I speak for myself it crazy but a lot of stuff sometimes goes on in the institution that I am completely unaware of. I focus on me and what's best for me and my future.
- 46. This prison is run by very petty people. There is no chance for convicts to start a new or rehabilitated life. We cannot do anything other than return to this prison or another. It's a damn shame.
- 47. They need help more than us, but let them tell us, they are the smart ones!!!
- 48. Counselors are supposed to be in a facility to help instead of telling you that they will not put sex offenders in for good time because it goes against their moral compass or tell your information to other inmates to make you look bad or just to gossip for them to tell other inmates.
- 49. Start a group that goes to prisons and finds out what really happens here. Then do something about it to fix the problems make people responsible for their actions.
- 50. Offer more programs also they want you to snitch to receive good jobs. Too many roaches in chow hall come check and see for yourself.
- 51. Say what you say
- 52. These people don't know how to speak with respect, they talk down to me, they are not better than me. I feel dehumanized on a regular basis.
- 53. I have lies by staff [NAME REDACTED] in writing, presented it in a grievance, and my grievance was still denied. I spoke to the warden about the issue and he responded, "I don't know, I am not clinical services," blatantly disregarding my concerns.
- 54. 1. They said if I got a G.E.D I'd get 90 days off. 2. They said to go for a G.E.D. I had to get 8.0 on TABE test. 3. I got 8.0 on TABE test. 4. I was told the G.E.D. education/test would not be offered. 5. Some people do bad on the test on purpose, so they can go to school and then get 45 days off."

- 55. The food and healthcare here need a total upgrade from top to bottom.
- 56. Help! Us please all
- 57. I wish this prison gets closed down and we all get re-located to a better prison.
- 58. It's a complete survey overall. Hopefully, issues will be looked into and/or addressed. The survey doesn't ask about treatment of ADA inmates, East Moline being the worst. As for my treatment and ADA needs, ADA inmates are often bullied by staff here.
- 59. Inmates and C/Os have relationships
- 60. The things that happen here I hate to say it, but an inmate one day will die here. I feel you people don't really care. Because if you did you would really look into this place and find the truth, you would see for yourselves the bullshit that's here. "Save us."
- 61. I think reforming the prison system since the governor came in and wanting change for the better and releasing good time to give those an early chance to get back their lives in the free world. And I know that are some improvements, and more work is needed with staff in how they conduct themselves as well as programs given. That free movement creates a positive feel and attitude for low security facilities. Have leadership that is truly quality at the top to set the standards for lower staff members, and allowing inmates to be an example to the younger. Inmates who should be rewarded as trustees and placed in special housing unit as they called honor dorm because of their work ethics to steer inmates in the right direction. And the most important to me is to have church members of Christianity that represent different faith or choice of denomination be told to come in. That would really make the difference to bring a peaceful atmosphere in all prisons I find is the solution to solve a lot of problems because it helps and is the answer toward change. When your faith in God is instituted, to those who choose and have a choice when opportunities are available.
- 62. The prisoners are not treated as in-custody individuals; how do I know this? Because it has taken me twelve years to get a MRI to learn [**DIAGOSIS REDACTED**], so explain to me how is prison life, when Wexford Health Sources, Inc., sees me simply as a budgetary costs cutting concern!
- 63. It was helpful and being thoughtful of the well-being of those incarcerated.
- 64. IDOC has a mission statement. If they would inquire that question, I wonder if it's any importance to the C/O's or this association that's handing out this survey. People want to change. But I know whoever is reading this feels secure by having your job. Do you want to feel sexually harassed and laughed at? How about being dismissed and ignored? Help us, this time! The higher ups are installing fear with the C/O's and nothing is being done because we're nothing but a bunch of idiots. I do not like being yelled at or feeling threatened by them just because they have an off-duty police officer mindset. All these C/O's are related or are engaged, boyfriend or girlfriend.
- 65. Would like to see concrete results of these surveys you do, and see if your efforts improve somewhat this prison system.
- 66. Blacks can have black cellmates. Whites can't have white cellmates. = Bullshit E.M.C.C.
- 67. Poor on health care. No time given to heal. No food given to heal!!! Takes too long to get medical help. Poor doctors. Doctors care more about IDOC than what is going wrong with you.

- 68. The female staff here are very disrespectful and they talk to us like we are unhuman, and they either are dating another CO staff member here so the male staff will come over and shake down your room, or give you a hard time and threaten you. The staff here at East Moline do not abide by the rules, and they stick together, even when they are wrong.
- 69. More reentry help
- 70. WE NEED HELP ASAP!! No one cares if we live or die!!!
- 71. Dietary needs to cut down on serving preserved food, which mostly contains high concentration of sodium and preservatives, which are harmful as people sitting mostly around incarcerated cooked food preferably.
- 72. I shouldn't have to take a TABE test to get a job. We need people who want to help us. Substance abuse would be great.
- 73. Please help clean up NRC cause that make you get in sewer water, give you cell with no lights, give you sheets with piss and blood on them.
- 74. People need to follow the rules and not get by they make it bad for the good people
- 75. [NAME REDACTED] are not giving individuals in custody our lawful right to receive 1/2 day earned program sentence credit (EPSC) for our participation in alcoholics anonymous AA and narcotics anonymous NA each day we are in either of these selfhelp programs as they do in other Illinois prisons and as outlined in the Illinois Statute 730 ILCS 5/3-6-3(2)(3.0)(4.2) Rules and regulations for sentence credit (revised July 1, 2021). [NAME REDACTED] told our AA group "If I give you guys your sentence credit do you know how many guys would show up." It's called Due process to the law of Illinois and they're not adhering to the law here. Nor will [NAME REDACTED] resubmit us for EDSC review after we've been denied the first time. Earned Discretionary Sentence credit can be resubmitted every 90 days according to [NAME REDACTED]. *Because of the heat in the pharmacy here all of our medication is compromised, which in my case are blood thinners to help me stay alive. *[NAME REDACTED] an education teacher here had to be shown by an inmate/student that he was teaching us an algebra formula for the equation of a line incorrectly and [NAME REDACTED] had a hard time saying he was wrong, he would only admit that he wrote it incorrectly on the chalk board.
- 76. The survey will be great if they're taken seriously.
- 77. The COs in this institution for the most part do a great job. Maintenance needs more help. My suggestions are due to the fact that I am doing an extended term in this prison (more than 5 years) and I have done 3 years here already.
- 78. Please allow a chance for everyone to be chosen for programs and school. I have no major offenses and a year left and yet people I came here with were chosen before me.
